Yuppie Puppy of Boston, LLC Hold Harmless Document

At **Yuppie Puppy of Boston, LLC** (referred to herein as “Yuppie Puppy of Boston, LLC”, “YPPC”, “us”, “we”, “pet sitter”) the utmost care will be given in watching both your pet(s) and your home. However, due to the extreme unpredictability of animals, we cannot accept responsibility for any mishaps of any extraordinary or unusual nature (i.e. biting, furniture damage, accidental death, etc.) or any complications in administering medications to the animal. Nor can we be liable for injury, disappearance, death or fines of pet(s) with access to the outdoors. The Pet Owner (referred to herein as “Pet Owner”, “Client”, “Owner”) hereby affirms that the information provided is true and correct, and agrees to indemnify and hold harmless the Service for any damages that may result to the animals, to the Service, to the Owner, or to third parties from inaccurate information being provided herein.

We agree to provide the services stated in this contract in a reliable & trustworthy manner. In consideration of these services & as an express condition thereof, the client expressly waives & relinquishes any & all claims against **Yuppie Puppy of Boston, LLC**, except for those arising from negligence. Client agrees to notify us of any concerns within 24 hours of any complaint.

All pets are to be currently vaccinated. Should the pet sitter be bitten or otherwise exposed to any disease or ailment received from the client's animal which has not been properly and currently vaccinated, it will be the client's responsibility to pay all costs and damages incurred by the victim.

Yuppie Puppy of Boston, LLC shall not be held legally or financially responsible for the loss, injury, or death of any pet(s) that the client has let outside, or has instructed the pet sitter to allow unsupervised access to the outdoors.

It is expressly understood & agreed that **Yuppie Puppy of Boston, LLC** shall not be held legally or financially responsible for any damage to client's property, or that of others, caused by the client's pet during the period in which they are in its care.

If a dog has a history of biting, **Yuppie Puppy of Boston, LLC** reserves the right to refuse services. Bites must be reported to the local authority as provided by law. The client will be responsible for all medical expenses & damages resulting from an injury to the pet sitter or other persons by the pet(s). Client agrees to indemnify & hold harmless **Yuppie Puppy of Boston, LLC** in the event of a claim by any persons injured by the pet(s).

The client has described fully any previous displays of aggression of ANY TYPE (including aggression toward other animals (or people) and same is a part of this agreement

The client hereby authorizes and empowers the pet sitter to walk/exercise the animals in the designated locations and public areas, enter the home, and feed the animals.

Yuppie Puppy of Boston, LLC accepts no responsibility for security of the premises or loss if other individuals have access to the home during the term of this agreement. Only **Yuppie Puppy of Boston, LLC** will perform pet care during all assignments unless prearranged with client.

Pet Sitter agrees to provide the services stated in this contract in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes any and all claims against said pet sitter except those arising from negligence or willful misconduct the part of the pet sitter.

The client shall not hold **Yuppie Puppy of Boston, LLC** legally or financially responsible for any damage to household or belongings, or any illness or injury to the pet that may occur during the period of service. The client will provide adequate means of securing the home & clear instructions for any security devices in operation. The client is solely responsible for ensuring that the premises (indoor & out) are pet-safe & **Yuppie Puppy of Boston, LLC** will not be held responsible for safety hazards left by the client.

In the event that **Yuppie Puppy of Boston, LLC** is required to employ a locksmith to gain entry into Client's premises due to a malfunction of the lock, or other door opening mechanism, the Client agrees to reimburse **Yuppie Puppy of Boston, LLC** for all costs incurred in addition to the hourly rate for special services fee. The client expressly gives **Yuppie Puppy of Boston, LLC** the authority to employ a locksmith on the client's behalf in the event of the aforementioned occurrences. Client agrees to hold **Yuppie Puppy of Boston, LLC** unaccountable for consequences related to the activities of the locksmith.

The client has the responsibility of disclosing unusual habits, known allergies, favorite hiding places, health problems, behavior such as "escaping" & the client is liable for additional costs that result from the omission of important information.

While **Yuppie Puppy of Boston, LLC** will make every effort to have a singular pet sitter, due to schedule, vacation, personal emergency or illness of pet sitter, client authorizes us to arrange for another qualified person to fulfill responsibilities as set forth in this contract.

Yuppie Puppy of Boston, LLC reserves the right to terminate this contract at any time, at its sole discretion; likewise, the client may terminate this contract at any time.

We will keep the clients veterinarian information on file and on Pet Check Technology™ on file. It is the client's responsibility to update us and the Pet Check Technology™ software on changes to this information. Should specified veterinarian be unavailable, pet sitter is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Client agrees to reimburse pet sitter for expenses incurred, plus any additional fee for attending to this need or any expenses incurred for any other home/food/supplies needed.

The client authorize this contract to be valid approval for present & future services so as to permit **Yuppie Puppy of Boston, LLC** to accept telephone reservations & enter my premises without additional signed contracts or written authorizations.

It is the client's responsibility to make us aware of any and all material changes in contact information, veterinarian information, alarm code information, and lock/key.

First time clients or clients with a history of late payment will be required to pay in advance, or provide credit card information, before services are rendered. **Yuppie Puppy of Boston, LLC** reserves the right to request full payment in advance before services are rendered. A \$35 NSF (non-sufficient funds fee) will be applied to all checks. A \$15.00 NSF Fee will be imposed on Credit Cards that are declined. A finance charge of 2% per month will be added to unpaid balances after fifteen (15) days. In the event it is necessary to initiate collection proceedings on the account, Client agrees to be responsible for all costs of collection, including but not limited to attorney's fees.

The client understands that **Yuppie Puppy of Boston, LLC** uses Pet Check Technology™ for scheduling and billing services. The client understands that billing will be done on a weekly basis, an invoice will be generated and the client's credit card will be charged upon generation of invoice.

The client authorizes **Yuppie Puppy of Boston, LLC** to charge the clients card, via Pet Check Technology™, for billed activities.

The client understands that there is a one-time Pet Check Technology™ initiation charge of \$25.00, which will be charged on the first billing cycle. Should the client lose the barcode magnet, there is a \$25.00 replacement fee.
